ORDER OF PROTECTION

NOW, on this _____ day of _____, 20 _____, the Petition for Order of Protection comes on for hearing, the petitioner appearing (pro se) (by and through her/his attorney, _____), and the respondent (appeared) (did not appear but was served with notice on _____). Upon the testimony presented the Court finds sufficient evidence to establish the existence of domestic abuse and, therefore, an Order of Protection should be granted.

IT IS, THEREFORE, ORDERED BY THE COURT THAT AT ALL TIMES HEREAFTER THE RESPONDENT SHALL NEITHER INFLICT NOR CAUSE ANY PHYSICAL HARM, BODILY INJURY OR ASSAULT UPON OR TO THE PETITIONER OR OTHER FAMILY OR HOUSEHOLD MEMBERS IN ANY MANNER OR BY ANY MEANS. FURTHER, THE RESPONDENT SHALL NOT CAUSE THE INFLICTION OF ANY FEAR OF IMMINENT PHYSICAL HARM, BODILY INJURY OR ASSAULT UPON THE PETITIONER OR OTHER FAMILY OR HOUSEHOLD MEMBERS BY THREATS OF SAME OR OTHERWISE.

FURTHER, it is ordered that the Respondent, either personally or through an agent, be prohibited from contacting the Petitioner or victim, except under the following conditions:

FURTHER, that Respondent is excluded from the residence occupied by the Petitioner and/or children either at the address shown in the Petition filed herein, or at any other residence in which the Petitioner and/or children may be present;

that Respondent is excluded from the current place of business or employment of the Petitioner, or any future place of business or employment during the term hereof;

that Respondent is excluded from any school which either of the minor children named herein may attend;

that Petitioner is awarded the custody of the minor child or children named:

the Respondent is ordered to contribute the sum of \$ _____ each (week) (month) toward the support of the minor child(ren), all such payments being paid through the Chancery Clerk's Office in the Greene County Courthouse, Paragould, Arkansas, such payments to commence _____, 20____;

that Respondent is ordered to pay spousal support in the amount of \$ _____ per (week) (month), with such payments being paid through the Chancery Clerk's Office in the Greene County Courthouse, Paragould, Arkansas, to commence on _____, 20____;

that visitation by the Respondent with the minor child(ren) will be as follows:

All court costs of this proceeding are assessed against the (Petitioner) (Respondent), together with such administrative costs as are required in the payment of child support;

Any law enforcement officer with jurisdiction is ordered to accompany the Petitioner/Respondent and to assist them in gaining possession of the residence as set forth herein or to otherwise assist in execution or service of the Order of Protection.

PURSUANT TO ACT 266 OF 1991, ANY VIOLATION OF THIS ORDER IS A CLASS A MISDEMEANOR CARRYING A MAXIMUM PENALTY OF UP TO ONE (1) YEAR IMPRISONMENT IN THE COUNTY JAIL OR A FINE OF UP TO ONE THOUSAND DOLLARS (\$1,000.00) OR BOTH OR MAY RESULT IN A FINDING OF CONTEMPT OF COURT WITH SUCH ATTENDANT PUNISHMENT AS THE COURT MAY DEEM PROPER. AND ANY LAW ENFORCEMENT WITH PROPER JURISDICTION SHALL ENFORCE THE TERMS HEREIN.
